## **Terms & Conditions:**

- 1. The applicant should be Bonafide Domicile Fishermen Registered with the Department of Fisheries having Fishing Licenses for at least three years.
- 2. The housing unit shall have a minimum plinth area of 25 sq.m with sanitation facility.
- 3. Assistance is subject to eligibility criteria and availability of funds under the scheme.
- 4. Preference/priority shall be given to Fisherman living below poverty line (BPL) subject to fulfillment of eligible criteria.
- 5. Mere submission of the application form does not confer any right to avail assistance under the scheme.
- 6. The Final Selection of the applicant shall be the domain of District Level Committee framed vide Govt. Order No. 944-JK(GAD) of 2020 dated:15-10-2020 and shall be guided by the necessary orders/guidelines/clarifications issued in this regard from time to time.
