The applications should be submitted in the office of respective District Officer, of Fisheries Department upto 20th of June 2024. Allotment of the units shall be made strictly keeping in view the feasibility status and availability of funds under the scheme.

Terms & Conditions:

- 1. The applicants will submit Detailed Project Report(DPR) with full justification & technical/ economical details, including capital cost and the recurring cost, specific time lines for implementation of project etc.
- 2. The applicants will provide documentary evidence of availability of requisite land (either own/registered lease document) free from encroachments and encumbrances, sources of finance like Banks consent to provide loan towards the Non-subsidy portion of the project cost or declaration by the beneficiary for own investing, necessary clearances permissions etc.
- 3. The short listing of the sites with respect to feasibility shall be carried out by the District Level Committee keeping in view the topography, climatic conditions and other parameters of the area amenable for establishment of intended units.
- 4. The Final Selection of the intended sites shall be the domain of District Level Committee framed vide Govt. Order No. 944-JK(GAD) of 2020 dated:15-10-2020 and shall be guided by the necessary orders/guidelines/clarifications issued in this regard from time to time.
- 5. The District wise tentative targets stand circulated vide this letter No. DF/Plg/2024/605-G dated: 30-04-2024. The targets can be increased or decreased depending on the demand of districts.
