The DDO shall draw arrears strictly in terms of rule 295 GFR2017 Circular No. A/23 (08)-1-B 184 dated 18.02.2021.

The DDO concerned shall allow the benefit of In-situ promotion in respect of concerned officials subject to the fulfillment of the following conditions.

1. That the DDO Concerned shall allow the benefit of in-situ promotion in respect of the officials only after satisfying himself about the eligibility.
2. That the incumbent was not under suspension or contemplated on any charge of charge-sheet under Classification Control and Appeal Rules 1956 or any other rules and their work and behaviour remained satisfactory.
3. That the present In-situ promotion shall not change/effect the existing designation/ seniority /duty.
4. That the benefit of HSPS shall not be given to such of the employee who has relinquished/forgone the functional promotion for any reason, whatsoever.
5. The Service verification up to the date of issuance of this order will be sole responsibility of the concerned DDO to check and record on the Service Book.
