A sum of ₹ 3,73,983/- out of aggregating amount of ₹ 8,28,149/- sanctioned in 07/2022 is still outstanding against the subscriber. Fresh advance of ₹ 4,00,000/- together with previous balance of ₹ 3,73,983/- aggregating to ₹ 7,73,983/- (**Rupees seven lac seventy three thousand nine hundred & eighty three only**) shall be recovered in 60 equal monthly instalments of Rs 13000/- and last being of Rs 6983/- Commencing from the salary of the month following the month of drawal of the advance.
