A sum of ₹ 5,40,000/- out of aggregating amount of ₹ 6,00,000/- sanctioned in 08/2024 is still outstanding against the subscriber. Fresh advance of ₹ 3,00,000/- together with previous balance of ₹ 5,40,000/- aggregating to ₹ 8,40,000/- (Rupees eight lac forty thousand only) shall be recovered in 60 equal monthly instalments of Rs 14200/- and last being of Rs 2200/- Commencing from the salary of the month following the month of drawal of the advance.
