A Floating Pelleted Trout Feed Mill, approved under the Holistic Agriculture Development Programme (HADP) during the financial year 2024-25, has been installed by the Mechanical & Hospital Division Anantnag at the Trout Fish Farming Project (TFFP) Kokernag. However, this Directorate has received several communications highlighting underperformance and various functional challenges affecting the reliability of the Feed Mill.
