ORDER NO. 377-Fisheries of 2025

- (ii) Whereas. Sh. Gh. Mohi Ud Din Magray (F/G) was attached by Joint Director Fisherics (North) Kashmir Division vide his office letter No. JDF/N/K/25-26/120-21 dated 19-04-2025 allegedly for spreading malicious gossip against senior officers.
- Whereas, Sh. Gh. Mohi Ud Din Magray (F/G) filed an OA NO. 392/2025 before the Hon'ble Central Administrative Tribunal, Srinagar with the prayer for quashment of the attachment order.
- Whereas, the Hon'ble Central Administrative Tribunal, Bench, Srinagar disposed of the Citi OA vide order dated 25-04-2025 with the direction to the respondent department "to initiate an inquiry into the matter in accordance with law by providing ample opportunity to the official to defend himself and to place any material before the competent authority. Thereafter the competent authority shall pass an order in accordance with law preferably within a period of ten days positively. The court has further directed that it would be in the interest of justice, if the said inquiry is conducted by the Director Fisheries, Srinagar himself and JDF North has been directed to place all the material pertaining to the allegations against the petitioner before the Director Fisheries. In case the Inquiry proceedings are not culminated with 10 days the competent authority may approach this court for extension of time. However, every endeavour shall be made to complete the inquiry within the stipulated period and the competent authority shall pass a reasoned and speaking order in accordance with law. The Court has further ordered that the compliance report be placed before the Court by 15-05-2025 as the same will be listed on said date for ensuring compliance of the order.
- Whereas, in compliance to the directions of the Hon'ble Tribunal, Inquiry was initiated in the matter and Joint Director Fisheries (North) Kashmir Division vide letter No. DOF-LGL/4/2025-05 dated 08-05-2025 was requested to furnish a detailed report along with all the relevant material for framing of charges.
- (v) Whereas, Charge sheet on the basis of report of JDF North Kashmir Division, was framed and served to the Sh. Gh. Mohi Ud Din Magray.

- (i) Whereas, Sh. Gh. Mohi Ud Din Magray (F/G) was given ample opportunity to counter the charges.
- (vii) Whereas, the committee examined the contents of the complaint/charge sheet and other material placed before it. The Committee also heard the official in person as well as examined the witnesses on whom the Joint Director Fisheries North was relying upon.
- (viii) Whereas. Sh. Gh. Mohi Ud Din Magray (F/G) denied the charges categorically and the witnesses named by JDF North in his report also categorically denied their involvement in the alleged gossip, consequently the allegations/charges leveled against the official have not been proved.
- (ix) Whereas, the committee has submitted its Inquiry report dated 17-06-2025 wherein the committee has recorded the details of Inquiry and has held that the charges have not been proved. The committee has further reported that the controversy has crupted due to misunderstanding and mis-communication which ought to have been settled amicably.

Now therefore, in the attending circumstances of the case, the charges leveled against Sh. Gh. Mohi Ud Din Magray (F/G) are dropped and the attachment letter No. JDF/N/K/25-26/120-21 dated 19-04-2025 of JDF North, Kashmir Division is hereby revoked ab-initio with the directions to the officer concerned not to act mechanically on rumours in future and without verifying the contents of complaint from reliable sources.
