Sub: Consideration Order in compliance to the Hon'ble Central Administrative Tribunal Order dated 23-05-2025 passed in OA No. 61/683 of 2025 titled Nek Chand V/S UT of Jammu and Kashmir and others

Order No. 447 Fisheries of 2025

Dated: 25-07-2025.

Whereas, final Seniority List of Field Supervisors (Jammu and Kashmir Divisions) has been issued by J&K Fisheries Department vide Order No. 49-Fisheries of 2025 dated 22-01-2025.

Whereas, Sh. Nek Chand is figuring at S. No. 15 in the Seniority list of Field Supervisors of Jammu Division.

Whereas, on 04-04-2025 a preliminary exercise was initiated for conducting DPC for the purpose of promotion of Field Supervisors/equivalent and Fisheries Guards/equivalent but Sh. Nek Chand didn't make it to consideration zone for want of vacancies.


Whereas, the Preliminary exercise made in the DPC meeting dated 04-04-2025 could not materialize due to some technical issues.

Whereas, the placement of Sh. Nek Chand as I/C Deputy Inspector in OPG was only for six months or subject to clearance by DPC. Furthermore, the charge allowance and the higher placement in OPG have been withdrawn by Director Fisheries vide circular No. DOF/Adm/2021/339/1678-1708 dated 06-07-2021.

Whereas, Sh. Nek Chand (Field Supervisor) approached the Hon'ble Central Administrative Tribunal, (CAT) Bench, Jammu with an O.A No. 61/683 of 2025. The Hon'ble Tribunal was pleased to dispose of the petition vide order dated 23-05-2025 with the direction to the respondents ***"to treat a copy of this O.A. as representation of the applicant and decide the same by passing a reasoned and speaking order. A copy of the speaking order be also furnished***

to the applicant. Let this exercise be completed within a period of eight weeks from the date of receipt of a certified copy of this order”.

Now in pursuance to the directions of the Hon'ble Central Administrative Tribunal, Bench, Jammu dated 23-05-2025 issued in OA No. 61/683 of 2025 titled Nek Chand V/S UT of J&K and others, the O.A has been considered as representation of the petitioner. The representation/s have been examined in light of the rules, maintenance of quota between direct recruits and Promotees and availability of vacancies under Promotion quota in Jammu Division and has been found devoid of any merit, hence rejected. However, the case of the petitioner will be referred to the DPC strictly under rules in due course of time subject to availability of vacancies and his eligibility.
