Sub: Consideration Order in compliance to the Hon'ble Central Administrative Tribunal Order dated 16-05-2025 passed in OA No. 570 of 2025 titled Deepak Chowdhary and others V/S UT of Jammu and Kashmir and others

Order No. 448 Fisheries of 2025

Dated: 25-07-2025.

Whereas, on 04-04-2025 preliminary exercise for DPC was conducted for the purpose of promotion of Field Supervisors/equivalent and Fisheries Guards/Equivalent.

Whereas, the Preliminary exercise made in the DPC meeting dated 04--04-2025 could not materialize due to some technical issues.

Whereas, the Rationalization of Non-gazetted Cadre and review of Subordinate Service Recruitment Rules is under process in the Administrative Department.

Whereas, petitioners approached the Hon'ble Central Administrative Tribunal, (CAT) Bench Jammu with an O.A No. 570 of 2025. The Hon'ble Tribunal was pleased to dispose of the petition vide order dated 16-05-2025 with the direction to the respondents "to treat this O.A as representation of the applicants along with the representation which is already pending before the competent authority and consider the case of the applicants before convening the DPC and decide their representation by passing reasoned and speaking order. The respondents are further directed to communicate the order so passed to the applicants. The entire exercise shall be completed with a period of eight weeks from the date of receipt of certified copy of this order".

Now in pursuance to the directions of the Hon'ble Central Administrative Tribunal, Bench, Jammu dated 16-05-2025 issued in OA No. 570 of 2025 titled Deepak Chowdhary and others V/S UT of J&K and others, the

O.A has been considered as representation of the petitioners. The O.A/ representations of the petitioners have been examined and the prayers/relief sought therein have been analysed. In this view of the matter, it is reiterated that the Rationalization of Non-Gazetted Cadre strength of Fisheries Department and Review of Sub-ordinate Service Recruitment Rules in terms of S.O 133 dated 29-03-2022 is under the consideration of Administrative Department. However, the services of MTS staff (executive cadre) cannot be brought at par with those of other Departments referred to in the representation unless Recruitment Rules of the Department are reviewed by competent authority to that extent. The representation of the petitioners being without any basis cannot be considered in given circumstances, hence rejected.
