A sum of ₹ 1,85,000/- out of aggregating amount of ₹ 8,00,000/- sanctioned in 01/2022 is still outstanding against the subscriber. Fresh advance of ₹ 4,00,000/- together with previous balance of ₹ 1,85,000/- aggregating to ₹ 5,85,000/- (Rupees five thousand only) shall be recovered in 39 equal monthly instalments of Rs 15000/- and last being of Rs Nil/- Commencing from the salary of the month following the month of drawal of the advance.

The official is not likely to retire before the liquidation of advance in full as the date of birth of the official is 15-07-1982 and the advance is within 75% of available balance so computed.
