**Subject: Constitution of a Committee for Streamlining Seed Distribution to Departmental and Private Fish Farms/Units-Reg.**

This Directorate has received a number of requests from private Fish Farmers, particularly from the districts of North Kashmir for the supply of Trout Fingerlings for the stocking in their units. In order to streamline the seed distribution system, a committee of the following officers, under the chairmanship of the Joint Director Fisheries, North (Kashmir) Division is hereby constituted to ascertain the actual availability of seed in the Departmental Trout hatcheries across Kashmir Division, for judicious seed distribution.

1. Chief Project Officer, Trout Fish Farming Project, Kokernag
2. Assistant Director Fisheries, District Ganderbal
3. Senior Project Officer, Trout Feed Mill, Manasbal
4. Assistant Director Fisheries, District Baramulla

The committee shall visit Departmental hatcheries across various Districts/Projects of the Kashmir Division to thoroughly assess the production/ availability of the seed and distribution to both Government and private farms. The committee shall compile the data as per the enclosed **Annexure-I** and furnish a factual report in this regard to this Directorate within **seven (07) days** positively, for further necessary action.

Besides, all District/Project Officers are hereby directed to refrain from supplying Trout seed to Government as well as Private farms until the factual report by the aforesaid committee is received by this Directorate.
