Order No. 698 - Fisheries of 2025.

Whereas the Joint Director Fisheries (South) Kashmir Division under No: JDF/K/S/2025/1476-77 dated: 16-09-2025 and Assistant Director Fisheries District Anantnag under No. ADF/ANG/2025-26/1992-94 dated: 11-09-2025 has reported that Shri Bashir Ahmad Rah, Fisheries Guard has drawn an amount of Rs. 28000/- (Rupees twenty-eight thousand only) out of sanctioned amount of Rs 75000/- (Rupees seventy-five thousand only)

Whereas an amount of Rs. 75000/- (Rupees seventy-five thousand only) was sanctioned compositely as house building advance in favour of the above noted official vide Fisheries Order No. 341 of 1996 dated: 31-03-1996 appearing at S.NO. 16 in the said composite sanction.

Whereas an amount of Rs. 28000/- (Rupees twenty-eight thousand only) out of total sanctioned amount of Rs. 75000/- (Rupees seventy-five thousand only) was released on account of house building advance by the FAO/CAO Housing and Urban Development Department Civil Secretariat vide Allotment order No: HUD/Acctts/356/NG/DQ Dated: 25-03-1998 for an amount of Rs. 28000/- (Rupees twenty-eight thousand only) in favour of the said official bearing House Building Advance account No. 4294-HBA allotted by Accountant General J & K.

Whereas the Assistant Director Fisheries Anantnag vide his letter No: ADF/ANG/2025-26/1992-94 dated: 11-09-2025 has categorically certified that only one installment of House Building Advance of Rs. 28000/- (Rupees twenty-eight thousand only) was drawn by the above official vide T.V No: 02 dated: 14-04-1998 from the date of sanction of the House Building Advance as the official was posted in Assistant Director Fisheries Anantnag for the period 06/2022 to 12/2022.

Whereas the above noted official has furnished SURETY BOND where he has affirmed that only one instalment of Rs. 28000/- out of the sanctioned amount of Rs. 75000/- on account of House Building Advance has been drawn by him till date. The official has also bind himself that the excess amount, if any drawn by him shall be recovered by the Government in lump sum with interest from his pension failing which the same shall be recovered as arrears of land Revenue.

 

Whereas all the records of the Directorate of Fisheries prior to April 2005 have been gutted in the devastating fire incident of Tourist Reception Centre Srinagar in May 2005, no records are available in this Directorate for the said period as the Directorate of Fisheries was housed in the Tourist Reception Centre Srinagar. Meanwhile, all the records prior to September, 2014 have also been damaged in the devastating floods in September, 2014.

In view of the above and as recommended by the Assistant Director Fisheries District Anantnag vide his No. mentioned above, the remaining balance of House Building Advance to the tune of Rs. 47000/- (Rupees forty-seven thousand only) is hereby cancelled in favour of Shri Bashir Ahmad Rah, Fisheries Guard with immediate effect. However, if it is found at any time that the official has drawn House Building Advance in excess of Rs. 28000/- (Rupees twenty-eight thousand only) the official shall be held liable for that besides an affidavit be sought to this effect from the official duly attested by 1st class Magistrate and the excess amount drawn by him shall be recovered in lump sum with interest from his pensioner benefits.
