Sub: Consideration Order in compliance to the Order dated 13-11-2025 passed by Hon'ble Central Administrative Tribunal, Srinagar, in OA No. 1319 of 2025 titled Imtiyaz Ahmad Shah V/S UT of Jammu and Kashmir and others

Order No. 782 Fisheries of 2025
Dated: 15-12-2025.

Whereas, a tentative Seniority list of Fisheries Guards (District Cadre), was issued by the Department vide notification issued under endorsement No. DOF-ESTB/196/2022-05 dated 06-07-2024 inviting the objections from aggrieved persons within 21 days.

Whereas, the Directorate of Fisheries received several representations from the aggrieved members of the cadre which were referred to the Departmental screening/Review committee for judicious disposal.

Whereas, the applicant Mr. Imtiyaz Ahmad Shah (Fisheries Guard) didn't file his representation/objections within specified time nor attended the office to register his claim.

Whereas, the Seniority of Fisheries Guards, (District Cadre) including that of District Kulgam was finalized vide order No. 47-Fisheries of 2025 dated 22-01-2025 wherein the applicant was placed at S. No. 08 and respondent No. 04 Mr. Javed Ahmad Ganie (Fisheries Guard) was placed at S. No.7.

Whereas, respondent No. 04 Mr. Javed Ahmad Ganie (Fisheries Guard) has been appointed as Chowkidar in the year 1994 while as petitioner has been appointed as Chowkidar in the year 1996.

Whereas, the respondent No. 4 has been promoted as Fisheries Guard vide Fisheries Order No. 253 of 1996 dated 14-12-1996 w.e.f 04-12-1996 and the petitioner has been promoted as Fisheries Guard Order vide order No. 354 of 1997 dated 13-01-1997 w.e.f 04-12-1996.

Whereas, the records are crystal clear that respondent No.4 is senior to petitioner, therefore they are rightly figuring in the Seniority list and placement of respondent No.4 has been made strictly as per rules.

Whereas, the date of appointment with respect to respondent No.4 has been inadvertently mentioned as 04-12-1996 instead of 01-04-1994 in the Seniority list, which will be set right by updating the seniority list.

Whereas, petitioners approached the Hon'ble Central Administrative Tribunal, (CAT) Bench Srinagar with an O.A No. 1319/2025 in hot haste and on wild guesses.

Whereas, the Hon'ble Central Administrative Tribunal, Bench Srinagar has been pleased to dispose of the OA vide order dated 13-11-2025 with the direction that **"respondent - Director, Fisheries, Srinagar, will consider and dispose of the representation filed by the petitioner dated 03-10-2025 in accordance with the rules governing the field with due dispatch by passing a speaking and reasoned order"**.

Now in pursuance to the directions of the Hon'ble Central Administrative Tribunal, Bench, Srinagar dated 13-11-2025 issued in OA No. 1319 of 2025 titled Imtiyaz Ahmad Shah V/S UT of J&K and others, the representation of petitioner dated 03-10-2025 has been considered, and has been found devoid of any merit, hence rejected.
