Sub: Settlement of absence period of Sh. Kewal Krishan (MTS)

ORDER NO. 144 - Fisheries of 2026
Dated: 16 -03-2026

- (i) **Whereas**, Sh. Kewal Krishan (MTS) remained unauthorizedly absent from his duties for 181 days w.e.f 01-08-2025 without permission.
- (ii) **Whereas**, a show cause notices was issued to the official by Assistant Director Fisheries, District Kishtwar vide No. ADF/Ktr/2025-26/1042-44 dated 26-02-2026 for resumption of duties and explanation of reasons of absence.
- (iii) **Whereas**, the official submitted reply to the show cause notice on 02-03-2026, wherein the official has submitted that he was suffering from Spinal injury which prevented him to report back to the duties/training as he was completely bed ridden and was dependent on the support of his family members.
- (iv) **Whereas**, the absence case of the official has been examined in light of medical exigencies faced by the official during his absence period.
- (v) **Whereas** the Joint Director Fisheries Chenab Valley Jammu vide his office letter No. **JDF/CV/J/2025-26/755-56 dated 09-03-2026** has recommended that lenient view may be taken and the absence period of 181 days w.e.f 01-08-2025 to 28-02-2026 of Sh. Kewal krishan (MTS) be treated as commuted Leave for 89 days w.e.f 01-08-2025 to 28-10-2025 and Earned Leave for 92 days w.e.f 29-10-2025 to 28-02-2026.

Now therefore, while taking considerate view in the matter and as per the recommendations of the Join Director Fisheries Chenab Valley and keeping in view the medical conditions of the official during his absence period, sanction is hereby accorded for the settlement of the absence period of Sh. Kewal Krishan (MTS) as under;
