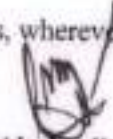

The acquisition shall be carried out in accordance with the provisions of the applicable land acquisition laws and rules in force and after fulfilment of all statutory requirements by the concerned authorities. The estimated cost of land acquisition amounting to **Rs. 77.00 lacs (Rupees Seventy Seven Lacs only)** shall be met from the funds available under the Capex Budget.
