➤ **Whereas,** the Administrative Department vide letter No. ASH/FSH/02/2020 dated 21-09-2020 forwarded Communication No. GAD (VIG) 41-RDA/2019 dated 11-08-2020 of General Administration Department for initiation of Regular Departmental Action (RDA) against above mentioned ex-officials/official in terms of provisions of J&K Civil Service (CCA) Rules, 1956.

➤ **Whereas,** a Committee was constituted by Director Fisheries vide order No.277 of 2020 dated 29-09-2020 for conducting inquiry in the

- **Whereas,** the designated Committee didn't submit its report for quite a long time and a reminder was issued to the chairman of the committee vide letter No. DF/ADM/2022/Misc dated 27-01-2022 for submission of action taken report.
- **Whereas,** General Administration Department issued OM No. GAD-VIGORDA/68/2024-02-GAD (CC:7539668) dated 05-02-2025 on the subject and sought action taken report on urgent basis.
- **Whereas,** Joint Director Fisheries North, being the chairman of the designated committee, was requested to furnish action taken report vide letter No. DOF-ESTB/76/2021-05 dated 25-02-2025. But the officer verbally reported that there is no such record in his office.
- **Whereas,** Mr. Gh. Mohi Ud Din Wani Joint director Fisheries, North Kashmir Division was appointed as Enquiry officer vide order No. 111-Fisheries of 2025 dated 27-02-2025 for conducting investigation in the matter in time bound manner.
- **Whereas,** the Enquiry officer conducted the inquiry and submitted the report along with his recommendations vide letter No. JDF/N/K/25-26/199-200 dated 28-04-2025, wherein the officer has reported that a detailed enquiry was conducted in the case. The Inquiry was conducted from multiple angles and no clue whatsoever was found with respect to the implication of aforementioned ex-officials who have retired from Government services except Mushtaq Ahmad Shah, Field Supervisor. Accordingly the Inquiry officer has emphasized that the said ex-officials/official were not involved in any incriminating /illegitimate act.
- **Whereas,** upon critical examination of records viz inquiry report, Article of charges, Statement of Imputation and other relevant material on record, it has been found that the charges have not been established against the ex-officials/official during the inquiry and no separate penal proceedings have been initiated against them by the concerned agencies. Accordingly, in the totality of the circumstances, it is observed that there is no sufficient and good cause or reason to proceed against the ex-officials/official.
- **Now therefore,** in light of the reasons referred hereinabove, (1) Mr. Ghulam Rasool Lone, the then Fisheries Development Assistant,



(2) Mr. Mohd. Sultan Lone, the then Field Supervisor, (3) Mr. Habibullah Lone, the then Field Supervisor, (4) Mr. Mushtaq Ahmad Shah, Field Supervisor, (5) Bashir Ahmad Ganie, the then Field Supervisor of Fisheries Department, are hereby exonerated of the charges levelled against them.
