Sub: Consideration Order in compliance to the Order dated 23-03-2026 passed by Hon'ble Central Administrative Tribunal Jammu in OA No. 1165/2024 titled Bandana Sharma V/S UT of Jammu and Kashmir and others

Order No. 327-Fisheries of 2026

Whereas, petitioner was transferred from the office of Assistant Director Fisheries District Poonch to the office of Assistant Director Fisheries Rajouri vide order No. 516-Fisheries of 2024 dated 11-10-2024.

Whereas, the petitioner assailed the said order before the Hon'ble Central Administrative Tribunal Bench Jammu in OA No. 1165/2024 titled Bandana Sharma VS UT of J&K and others.

Whereas, the Hon'ble Tribunal was please to stay the impugned order qua the applicant vide order dated 24-10-2024.

Whereas, the Hon'ble Tribunal vide Order dated 23-03-2026 has observed as under;

"The petitioner has been given in-charge posting as Senior Assistant which happens to be a Divisional Cadre post, however, many persons who were promoted with same order have been kept in their same District from which they were transferred. So, respondents are directed to consider the request of the petitioner in the light of similar orders passed by the respondents, and pass a speaking order. Put up for consideration on 20.04.2026."

Now in pursuance to the directions of the Hon'ble Central Administrative Tribunal, Bench, Jammu dated 23-03-2026 issued in OA No. 1165/2024 titled Bandana Sharma V/S UT of J&K and others, the request of the applicant has been considered and rejected being devoid of any merit as the placement/ transfer of the official has been effected in the sheer interest of administration and smooth functioning of Departmental work. Moreover, conceding to the request of the official shall set a bad precedence in the Department and other officials will start requesting for similar treatment.
