A sum of ₹ 1,34,644/- out of aggregating amount of ₹ 7,71,000/- sanctioned in 06/2022 is still outstanding against the subscriber. Fresh advance of ₹ 9,00,000/- together with previous balance of ₹ 1,34,644/- aggregating to ₹ 10,34,644/- (Rupees ten lac thirty four thousand six hundred & forty four only) shall be recovered in 52 equal monthly instalments of Rs 20000/- and last being of Rs 14644/- Commencing from the salary of the month following the month of drawal of the advance.

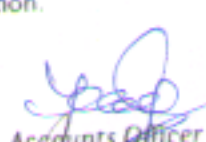
