Subject: **Constitution of Committees for round-the-clock monitoring of Fisheries Department establishments and assets in view of prevailing adverse weather conditions.**

In view of the prevailing adverse weather conditions in the Union Territory of Jammu and Kashmir and the likelihood of heavy rainfall, flash floods, landslides and other weather-related incidents, the following Committees are hereby constituted to closely monitor the situation, remain in constant coordination with the field formations and ascertain the status of all Fisheries Department establishments, infrastructure, fish farms, hatcheries and other departmental assets within their respective jurisdictions:

A. Kashmir Division

3. Senior Project Officer, Survey Division.

B. Jammu Division

1. Joint Director Fisheries, Central Jammu. (7006598336)
2. Chief Project Officer, RFFDA, Jammu.
3. Senior Project Officer, Marketing Division, Jammu.

The Committees shall remain vigilant and maintain **round-the-clock coordination and monitoring** during the period of adverse weather conditions. They shall obtain regular updates from the concerned field officers and subordinate offices regarding any damage, disruption, threat or other adverse impact on live stocks, departmental infrastructure, fish farms, hatcheries, reservoirs and other departmental assets.

The Committees shall ensure **immediate reporting of any emergent situation** and take appropriate remedial and preventive measures at their level, wherever required, while promptly bringing any matter requiring intervention of the Directorate to its notice.

The Committees shall submit a **consolidated status report to the Directorate every six hours**, or immediately in the event of any serious or emergent situation requiring urgent intervention.

The concerned Joint Directors and other designated officers shall ensure effective coordination, continuous monitoring and timely reporting by all field functionaries under their respective jurisdictions.
