Sub: Suspension of official pending departmental enquiry.

Whereas, during the surprise visit to Fish Farm Kohru (Langate), Handwara, District Kupwara by the Director Fisheries, J&K, on 19.07.2026.

Whereas, the following officials were found absent from duty without prior permission or sanctioned of leave from the competent authority:

1. Sh. Farooq Ahmad Ganie, FDA;
2. Sh. Mohd. Iqbal Chechi, Field Supervisor;
3. Sh. Sheikh Gh. Mohi-ud-Din, Fisheries Guard;
4. Sh. Mudasir Majeed Shah, Fisheries Guard; and
5. Sh. Feroz Aziz Banday, Fisheries Guard.

Whereas, the unauthorized absence from duty, prima facie, constitutes misconduct and amounts to dereliction of official duty, warranting disciplinary action under the applicable service rules;

Now, therefore, in exercise of the powers conferred under Rule 31 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, as applicable, the competent authority hereby places the aforesaid officials under suspension with immediate effect, pending departmental inquiry/disciplinary proceedings.

During the period of suspension, the suspended officials shall remain attached to **Trout Fish Farm, Laribal, Dachigam, Srinagar**, and shall not leave the headquarters/place of attachment without obtaining the prior permission of the competent authority. The suspended officials shall be entitled to subsistence allowance and other admissible allowances, as admissible under the rules.

The Assistant Director Fisheries, District Kupwara, is hereby directed to make necessary arrangements from amongst the available staff for the smooth functioning of the Fish Farm until further orders. He shall also submit a detailed report regarding the unauthorized absence of the aforesaid officials, along with their relevant attendance records, leave records, duty rosters and all other supporting documents, to this Directorate within three (03) days from the date of issuance of this order, for further necessary action under the rules.
