Terms of Reference

The Committee shall:

1. Assess all Government Trout Hatcheries in Kashmir Division with regard to the number of Trout eggs planted and the quantity of seed produced during the last two financial years.
2. Verify and compile hatchery-wise details of seed supplied to Government and private farms against cash payment, under different schemes/programmes, and under any other category of distribution.
3. Examine the relevant records/registers maintained at the hatcheries and assess the accuracy of production and distribution figures.
4. Visit all departmental Trout farms in the Division and assess the requirement of seed/livestock for stocking, including fry, fingerlings and yearlings for the financial year 2026-27.

The committee shall submit a comprehensive report along with hatchery-wise and farm-wise statements, observations and recommendations to the Directorate of Fisheries within 15 days from the date of issuance of this order.



All the concerned officers/officials shall extend full cooperation and provide all records and information required by the Committee for completion of the assigned task within the stipulated time frame.
