In continuation to the orders issued regarding the suspension of officials of District Kupwara, a Committee comprising of the following officers, is hereby constituted to conduct a thorough departmental enquiry into the allegations/charges levelled against the suspended officials and to ascertain the facts and circumstances of the matter;

The Committee shall:

1. Examine the allegations/charges levelled against the suspended officials and scrutinize all relevant records and documents pertaining to the matter.
2. Afford reasonable opportunity to the concerned officials to submit their statements/defence in accordance with the applicable service rules and principles of natural justice.

3. Examine the statements of witnesses and other persons, wherever considered necessary for arriving at a fair and objective conclusion.
4. Ascertain the facts and circumstances leading to the alleged misconduct/irregularities.
5. Record specific findings on each allegation/charge on the basis of the evidence and material available on record.
6. Identify responsibility, wherever established, strictly on the basis of the evidence brought on record.
7. Submit a **detailed enquiry report**, containing specific findings on each charge/allegation along with its recommendations, to the Directorate **within 15 days from the date of issuance of this order.**

The Committee shall ensure that the enquiry is conducted **fairly, objectively, impartially and expeditiously**, in accordance with the applicable service rules and established principles of natural justice.

The **Presenting Officer** shall place the relevant records, documents and other material before the Committee and assist the Committee in presenting the case against the concerned suspended officials.
