Fund advance of ₹ 5,00,000/- (Rupees five lacs only) in favour of Shri Sajad Ahmad Jan designated as I/c Dy. Inspector out of his G.P. Fund computer code 710106436 to enable him to defray the expenses in connection with Purchase of consumer durables.

A sum of ₹ 3,80,000/- out of aggregating amount of ₹ 5,00,000/- sanctioned in 02/2025 is still outstanding against the subscriber.
