at site i.e. Trout Fish Farms having trout hatcheries across the various Districts of the UT of J&K. Any deviations from the standard quality requirements shall be promptly addressed by the supplier, who shall take corrective action or provide suitable replacement as necessary at the cost of supplier.

- 7. The trash fish supplier must adhere to the designated size range of 30-80 mm, consisting of species such as *Crossocheilus, Triplophysa, Nemacheilus,* Puntius or any other local /native species. Any trash fish that exceeds or falls below this specified size range will be promptly returned to the supplier, and no payment will be made for the quantity in question.
  - 8. The trash fish shall be supplied for a period of 03 months or till onset of breeding season or post breeding operations to be distributed in equal proportions of the required quantity at farms as per bio mass of brood stock. And each proportion should be supplied on alternate days to maintain a fair and consistent feeding schedule. The quantity mentioned can be decreased or increased depending on the actual requirement.
  - 9. The trash fish shall be received in presence of a team of officers / officials to be nominated by the concerned District / Project Officer who shall ensure the receipt/ verification of the supplies in presence of the nominated committee. ## 11. Performance Bank Guarantee (PBG):

Within 15 days of notifying the acceptance of a proposal for award of contract, each qualified bidder shall have to furnish Performance Bank Guarantee (PBG) amounting to 5% of the total contract value from a scheduled/commercial bank in favor of "Chief Operating Officer, Himayat Mission Management Unit, Department of Rural Development & Panchayati Raj, J&K". PBG must be valid from the date of effectiveness of the contract to a period of 03 months beyond the expiry of contract as its commitment to perform services under the contract. Failure to comply with the



requirements shall constitute sufficient grounds for the forfeiture of the PBG. The PBG shall be released after 3 months of expiry of contract provided there is no breach of contract on the part of the qualified bidder. No interest shall be paid on the PBG and no exemption on PBG will be allowed.
