under the **Holistic Agriculture Development Programme (HADP)**, with a **unit cost of Rs. 25.00 lakhs per laboratory** during the current fiscal year.

- Fish disease investigation
- Analysis of trout feed ingredients
- Testing of soil texture and quality
- Analysis of water parameters essential for fish survival and culture
