- Note 2: The tenderers are required to go through the terms and conditions minutely and clear any doubt before submitting their tenders. The tenderer shall sign each page of this document in token of acceptance of the terms and conditions mentioned herein and submit the same along with the rate offer.

 General instructions /Terms and conditions:-
 - 1. The tender should be uploaded from the official website (www.jktenders.gov.in) and the following documents (Technical bid):
 - a. Call Deposit Receipt for an amount of Rs.100000/- Rupees one lakh thousand only.
 - b. Registration certificate from Competent Authority for being registered dealer/Supplier.
 - c. Attested copy of GST Number.
 - d. Tender Document duly signed.
 - e. Income Tax clearance of Last two years.
 - f. DD for an amount of Rs.1500/- on account of Tender Document fee.

Second Bid shall contain Financial Bid.

- 1. The tender document shall be downloaded from 17-02-2020 against payment of Rs.1500/- (Non-Refundable) pledged to Accounts officer Fisheries Department in shape of Demand Draft and shall be uploaded from official website www.iktenders.gov.in upto 09-03-2020. The hard copies shall be delivered personally or sent by registered post at Directorate office Nowabad, Canal Road Jammu 180016 by or before 10-03-2020 upto 4PM. The tender shall be opened on 11-03-2020 or any other date which shall be notified on departmental notice board convenient to opening authority in presence of tenderers who may like to be present. However, if the tender opening day happens to be a holiday or office remains closed due to any other reason, then tenders shall be opened on next working day. Direct or indirect canvassing on the part of tenderers or their representatives shall render his/their tender as disqualified.
- 2. The tender shall be accompanied by CDR for the amount of Rs 100000/- (Rupees one lac only) of a scheduled bank and pledged to Accounts officer Member Secretary State Level Purchase Committee. The registered SSI units shall furnish the CDR for such amount as is applicable in their favour as per standing Govt. Instructions. They shall have to make available copies of relevant Govt. orders entitling them to furnish CDR for lesser amount or any other concession/preference etc. Such units shall furnish proof of being registered SSI Units (Attested Photostat copy of Registration certificate) manufacturing the items and their units being functional.
- The rates shall be written neatly both in words and figures without correction, overwriting or ambiguity etc. The rates written shall be sealed with transparent tape. No conditions shall be written on the tender form. Conditional tenders shall be rejected.
- 4. The successful tenderer shall in no case sublet his contract for supplies to any person or agency.
- 5. The rates offered shall be inclusive of all taxes, duties, GST, carriage or any other incidental charges etc. and the same shall be FOR stores of Nodal Officer Fish Market New Delhi and Chief Project officer Trout Fish Farm Kokernag Kashmir and Chief Project officer Trout Fish Farm Laribal (Gagribal) Srinagar Kashmir. No escalation of rates on any account/reason shall be allowed and the entire supplies for which supply order is placed with successful tenderer (in phased manner during contract of one year) have to be made at the approved rates mentioned in the supply order that is placed with the successful tenderer.



- The department can if need arises, verify various documents such as Registration Certificate, Income Tax/Sales Tax, Clearance Certificates etc, furnished by the supplier from concerned departments.
- 7. The approved/accepted rates shall be valid for one year from the date of issuance of rate contract.
- CDR of successful tenders shall be released only after successful completion of the contract. The CDR
 of II and III lowest tenderer shall be released after two (2) months from the date of issuance of supply
 order/allotment in favour of successful tenderer.
- 9. The successful tenderer shall have to execute an agreement on (non-judicial paper of Rs.5/- with attestation of Notary) with the department for due fulfilment of the terms of NIT/supply order. However in case of failure to execute such agreement, the terms and conditions of NIT/Rate contract shall be still binding upon him.
- The supply order shall depend on availability of funds and requirement of the department from time to time.
- 11. The supplies shall be of standard quality strictly as per specifications mentioned in supply order free from defects. In case Machinery/Equipments s are found below standard or defective, same shall be rejected at the risk and cost of supplier. For this purpose the department shall frame inspection/verification committee which will ascertain the quality of Machinery/Equipments and also verify the supplied items by the supplier before taking such Machinery/Equipments on books.
- 12. The ordered quantity shall have to be supplied within 10 days from the date of issuance of supply order by the Department. Supplier is required to remain in touch with the department to ascertain the requirement of items from time to time. Copy of the supply order shall be sent to the address of the supplier. In case supplier makes any delay in supplying the required items the same shall be arranged from any other alternate sources at his risk and cost.
- 14 Payment of the supplies dully verified and accepted as per the conditions mentioned above. The supplier is also required to furnish the Xerox copy of his PAN CARD as well. Deduction @ 2% on a/c of TDS on GST supposed to be deducted where ever applicable at source, implemented vide SRO 433 dated 29-096-2018 w.e.f 01-10-2018 shall be deducted from each supply, as rate contract exceeds 2.5 lacs.
